**65.01 THROUGH STREETS – STOP.** Every driver of a vehicle shall stop, unless a yield is permitted by this chapter, before entering an intersection with the following designated through streets.

(Code of Iowa, Sec. 321.345)

- 1. Main Street, from Highway 75 to the west City limit.
- 2. Highway 75, from the north City limit to the south City limit.
- 3. Calhoun Street, from Highway 75 to Fifth Street.

**65.02 STOP REQUIRED.** Every driver of a vehicle shall stop in accordance with the following:

(Code of Iowa, Sec. 321.345)

- 1. Fowler Avenue. Vehicles traveling west on Fowler Avenue shall stop at Fifth Street.
- 2. Fourth Street. Vehicles traveling north on Fourth Street shall stop at Fowler Avenue.
- 3. Hills Street. Vehicles traveling west on Hills Street shall stop at Fifth Street.
- 4. Center Street. Vehicles traveling east on Center Street shall stop at Fifth Street.
- 5. Frost Street. Vehicles traveling south on Frost Street shall stop at Center Street.
- 6. Douglas Street. Vehicles traveling on Douglas Street shall stop at Fifth Street.
- 7. Douglas Street. Vehicles traveling on Douglas Street shall stop at the railroad tracks.
- 8. Douglas Street. Vehicles traveling east on Douglas Street shall stop at Third Street.
- 9. Webster Street. Vehicles traveling east on Webster Street shall stop at Third Street.
- 10. Webster Street. Vehicles traveling on Webster Street shall stop at Fifth Street.
- 11. Lincoln Street. Vehicles traveling east on Lincoln Street shall stop at Third Street.

- 12. Sixth Street. Vehicles traveling south on Sixth Street shall stop at Webster Street.
- 13. Calhoun Street. Vehicles traveling on Calhoun Street shall stop at Fifth Street.
- **65.03 FOUR-WAY STOP INTERSECTIONS.** Every driver of a vehicle shall stop before entering the following designated four-way stop intersections:

(Code of Iowa, Sec. 321.345)

1. Intersection of William Street and Fifth Street.

**65.04 YIELD REQUIRED.** Every driver of a vehicle shall yield in accordance with the following:

(Code of Iowa, Sec. 321.345)

#### "NONE"

65.05 SCHOOL STOPS. At the following school crossing zones every driver of a vehicle approaching said zone shall bring the vehicle to a full stop at a point ten (10) feet from the approach side of the crosswalk marked by an authorized school stop sign and thereafter proceed in a careful and prudent manner until the vehicle shall have passed through such school crossing zone.

(Code of Iowa, Sec. 321.249)

#### "NONE"

65.06 STOP BEFORE CROSSING SIDEWALK. The driver of a vehicle emerging from a private roadway, alley, driveway, or building shall stop such vehicle immediately prior to driving onto the sidewalk area and thereafter shall proceed into the sidewalk area only when able to do so without danger to pedestrian traffic and shall yield the right-of-way to any vehicular traffic on the street into which the vehicle is entering.

(Code of Iowa, Sec. 321.353)

- **65.07 STOP WHEN TRAFFIC IS OBSTRUCTED.** Notwithstanding any traffic control signal indication to proceed, no driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk to accommodate the vehicle.
- 65.08 YIELD TO PEDESTRIANS IN CROSSWALKS. Where traffic control signals are not in place or in operation, the driver of a vehicle shall yield the right-of-way, slowing down or stopping, if need be, to yield to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection.

SECTION 1. NEW SECTION. The Code of Ordinances of the City of Merrill, Iowa, is amended by adding a new Section 65.02.14 entitled STOP REQUIRED, which is hereby adopted to read as follows:

- 65.02.14 STOP REQUIRED. Every driver of a vehicle shall stop in accordance with the following:
- 14. Roosevelt Street. Vehicles traveling on Roosevelt Street shall stop at Third Street.
- SECTION 2. REPEALER. All ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.
- SECTION 3. SEVERABILITY CLAUSE. If any provision or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

SECTION 1. NEW SECTION. The Code of Ordinances of the City of Merrill, Iowa, is amended by adding a new Sections 65.02.15 and .16 and .17 entitled STOP REQUIRED, which is hereby adopted to read as follows:

- 65.02 STOP REQUIRED. Every driver of a vehicle shall stop in accordance with the following:
  - .15 Fifth Street. Vehicles traveling south on Fifth Street shall stop at Roosevelt Street.
- .16 Sixth Street. Vehicles traveling north from the Merrill City Park to the intersection of Sixth Street and Webster Street shall stop at Webster Street.
  - .17 Webster Street. Vehicles traveling west on Webster Street shall stop at Sixth Street.
- SECTION 2. REPEALER. All ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any provision or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
